PROPOSED NEW DEVELOPMENT ON ERF 3991, DIAS ESTATE, DIAS BEACH, MOSSEL BAY

Your email correspondence dated 14 July 2022 regarding the above subject matter, bears reference.

After a consultation meeting between the municipality and Messrs. from the Developer/(s), the municipality has no objection against the proposed development subject to the following:

- (1) Main access must be off Beach Boulevard East and in terms of Red Book and Western Cape Government Road Access Management Guidelines, taking cognizance of access spacing, sight distances, etc;
- (2) The alignment of a section of Beach Boulevard East must be considered in order to improve sight distance;
- (3) The introduction exclusive turning lanes;
- (4) With the proposed re-alignment and geometric changes to the horizontal layout of Beach Boulevard East, some existing parkings will be affected. The Developer/(s) of Erf 3991 must determine, in conjunction with the municipality, whether any historic agreements exist with the usage of such parkings;
- (5) The removal or relocation of existing trees. This is subject to approval by Cape Nature and/or the Department of Environmental Affairs;
- (6) Stormwater management under Chapter 5 of the Services Report, together with proposed stormwater layout drawings, are considered preliminary and must be submitted to the Infrastructure Services Department for consideration.
- (7) Stormwater must be handled on site as no Bulk Stormwater System is provided for.

Details to the above will be covered under a Services Agreement between municipality and Developer/(s) of Erf 3991.
