Hopes to take our town off the grid

In another first for Mossel Bay, the possibility of becoming self-sufficient in providing for the town's energy needs will be investigated.

On Monday morning the executive mayor and his mayoral committee asked the municipal manager, Adv Thys Gillomee, and his directorate to investigate the possibility of the Mossel Bay Municipality to be less dependent on the Eskom grid.

Energy insecurity, based on the renewed threat of load shedding

In December 2019 South Africa suffered the largest rolling power blackouts in its history after more than a quarter of the generating capacity at its troubled electricity provider broke down. Economists have since warned that South Africa could enter its second recession in as many years in 2020 because of the power cuts.

The need, therefore, to safeguard the local economy has become very real.

The imminent drastic and continuing escalation of electricity prices is deemed a very real threat to the municipality's efforts to attract investment and employment opportunities to the town. The municipality is exploring various economic development opportunities to grow the local economy. The sustainable and, eventually more affordable, supply of power across the energy spectrum, including green energy and gas, is deemed a competitive advantage that will attract both local and international investment. "Mossel Bay has for some time mooted the establishment of a Special Economic Zone (SEZ). Positioning Mossel Bay as an SEZ would be of great strategic benefit to not only the greater municipal area but also the region as there is no SEZ between Cape Town and Port Elizabeth.

"Considering the town's infrastructure, such as the harbour, airstrip, and proximity to the George Airport, the well-maintained local road infrastructure, and national highway, Mossel Bay is ideal for establishing an SEZ," municipal spokesperson Colin Puren said.

Local businesses support the proposal of SEZ

However, international investors will not invest if the Mossel Bay SEZ cannot guarantee sustainable and affordable energy. The growing national demands for higher and escalating electricity tariffs are seen as a potential threat to local economic

development that the municipality can effectively counter through self-sustainability.

The Mossel Bay SEZ would be unique as it would benefit from the oil, gas and related product industries, as well as from waste reduction and recycling, considering the proximity of the planned regional waste site.

Therein lies the opportunity for the municipality to become less dependent on the national electricity provider.

Mossel Bay Municipality has proven experience in employing green energy. The two offices of the Infrastructure Services Department recently implemented a 20kWp rooftop photovoltaic (PV) system when 81 installed solar panels were activated.

These offices now use the sun to generate sufficient electricity to run the offices and state-of-the-art equipment and systems used to ensure that the town's electricity, water supply, and sewerage systems operate optimally. To promote greater energy efficiency and the use of green energy, the infrastructure department took the lead to install systems that will eventually not only promote energy self-sustainability across all of the municipality's various buildings, but allow for surplus electricity to be exported (sold back) into the grid.

The local economy faces both the insecurity of PetroSA's future on the one hand and the excitement of the offshore exploration for gas and condensates with the Brulpadda and Paddavissie prospects in the Outeniqua Basin, 175km off Mossel Bay.

The challenge is to investigate the viability of the municipality being able to produce sustainable energy through several alternative sources including wind, gas and solar, that are economically viable to make Mossel Bay less dependent, if not independent of the national electricity provider.

It is envisaged that the town's load demand growth will escalate to approximately 100 MW within the next ten years.

Potential investors may be attracted by the proven track record of Mossel Bay Municipality, recognised as the best municipality in South Africa.

Being able to guarantee sustainable, uninterrupted and more affordable energy, along with the municipality's strong client-focused and service orientated approach, will provide the unique strategic advantage necessary to cement sustainable investment.

Weerlig op Mosselbaai

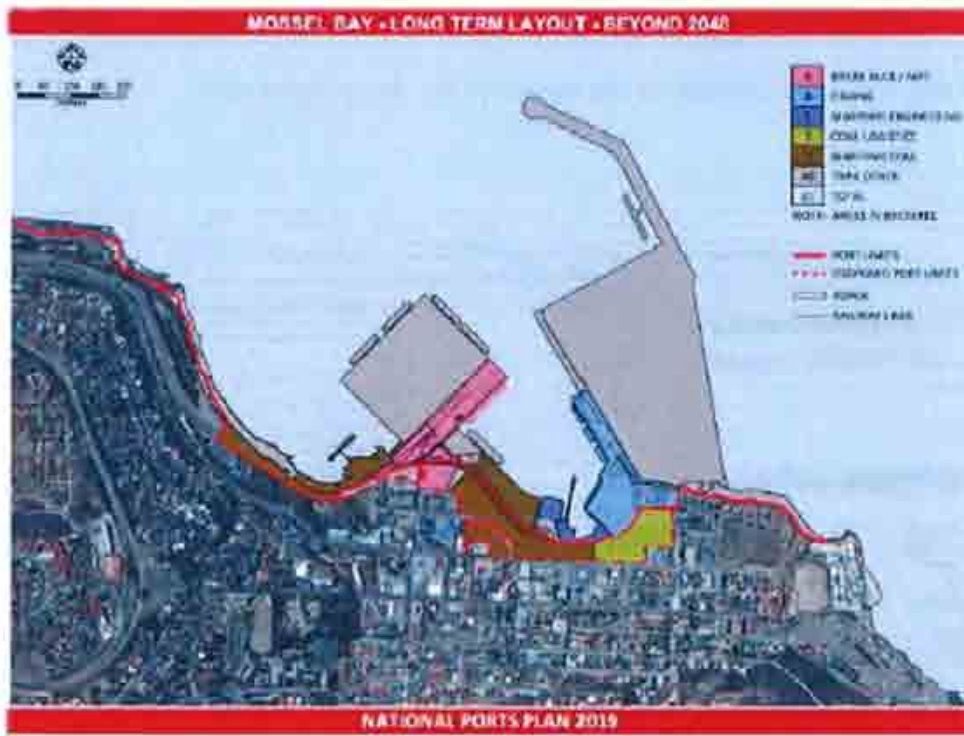

The latest development upsetting Afro Fishing which has plans to expand its Mossel Bay operation, was played out in the Cape High Court in late December 2019. The company had attempted to “gag” [mosselbayonline](#), a local news website, but lost.

Afro Fishing for its part wanted [mosselbayonline](#) to remove certain articles from its website and Facebook page pertaining to the ongoing international [#fishrot](#) scandal. [Mosselbayonline](#) maintains there is a connection between Afro Fishing’s director /possible shareholder and/or funder with the beleaguered Namibian state-owned fishing company Fishcor.”

[Mosselbayonline](#) said it had “merely quoted leading newspapers in Namibia and elsewhere.” It says the judge agreed that the articles were “not defamatory or malevolent”, and that the “information is factually correct and true.”

It also claims that “it is in public interest that residents have the right to know who Afro Fishing’s directors, shareholders and financiers are and what their involvements entail in fishing industries in

Namibia, Angola and elsewhere.”

[Mosselbayontheline](#) says it has “recommended that Afro Fishing’s Public Participation Process be postponed by all relevant authorities, including the Mossel Bay Municipality, until the #fishrot investigation has been completed.”

Judge Siraj Desai has not yet submitted the reasons for his judgement.

Resistance to development

Nonetheless, the [mosselbayontheline](#) editor and owner, seems to have an issue with Afro Fishing’s plans to redevelop its’ harbour facility to include a fish meal and oil reduction plant. The cost of the expansion plans is estimated at R380-million which includes state-of-the-art RTO technology.

There has been a lot of negative reporting about Afro Fishing’s plans and the town’s people have been roped in to resisting the development of the plant.

This has taken the form of an online petition, significant media coverage via the online facility and Noseweek magazine (which was also asked to retract some of its incorrect statements and did so), and numerous complaints and objections to the local councils concerned.

Fishrot scandal links

[Mosselbayontheline](#) has picked up on the Namibian 'fishrot' corruption scandal and claims through its research that there is a link to the Afro Fishing development. The link is focused on one individual, namely Johan Breed who is the only new director appointed after Afro Fishing changed hands in 2017.

Breed is MD of the Angolan-based African Selection Trust (AST) which was established by his father. AST owns African Selection Fishing Namibia which has a significant 60% shareholding in Seaflower Pelagic Processing (Pty) Ltd. Fishcor owns the remaining 40% shares.

He also sits on the board of directors of Seaflower Pelagic Processing (Pty) Ltd.

Furthermore, Breed is director of some eight other South African companies in the fishing industry. These are Afro Fishing Vessels (Pty) Ltd; Big O Trading 315 CC; K201844187 (South Africa) (Pty) Ltd; Mossel Bay Processors (Pty)Ltd; Mosselbay Pelagic Processors (Pty)Ltd; Princess Brand (Pty)Ltd; Vitoria E Certa (Pty)Ltd and Vitoria Fishing(Pty)Ltd.

Two other people were also named. They are South African economist Adriaan Jacobus (AJ) Louw and lawyer Marén de Klerk, representing AST on Seaflower Pelagic's board of directors.

Afro Fishing's response

Fishing Industry News Southern Africa approached Afro Fishing for their official response to the court case. This is the statement as follows:

"On 18 December 2019 Afro Fishing and Johan Breed brought an urgent application against Elsa Wessels ([mosselbayontheline](#)) to interdict her from publishing incorrect information and defaming the applicants.

"The application was dismissed, and Judge Desai has yet to supply reasons for his judgement. Afro Fishing and Johan Breed respect and accept the judge's decision and await the reasons for his decision.

"Afro Fishing and Johan Breed are not involved in the Icelandic scandal in Namibia, and any inference hereto is simply malicious. Afro Fishing and Johan Breed are not being investigated and no investigation is pending.

"The court ruling and the Icelandic scandal will not affect the Basic Assessment and Review process and any statutory requirements regarding the proposed project in the Port of Mossel Bay.

"The public participation period ran from 12 November 2019 to 12 December 2019. A public participation meeting was held in the Mossel Bay Town Hall on 20 November 2019.

"The Basic Assessment and Review process provides for a period until 11 February 2020 for Afro Fishing to address and respond to objections or comments received during the public participation period.

"We are aiming to update and submit the BAR to Department of Environment by end January 2020.

"Once received the department has a statutory period of 112 days to record a decision. There is allowance made for an appeal process thereafter.

"Afro Fishing will abide by all statutory requirements of the Basic Assessment and Review Process."

Rower wat vrou wurg gestraf

'n Man wat op Jeugdag, 16 Junie verlede jaar 'n vrou by 'n woonkompleks in Duijsstrand tydens 'n huisrooftog aangerand en vir dood agtergelaat het, is verlede Vrydag 13 jaar gevangenisstraf opgelê. Die veroordeelde, Zonovan Matthee (22) het die slagoffer, 'n vrou, se woning in die Twee Kuilen-kompleks omstreeks 06:30 binnegegaan. Sy het wakker geword toe hy haar kamer binnekom waarna hy haar aangerand en probeer verkrag het. Matthee het die vrou gewurg totdat sy haar bewussyn verloor het. Toe die vrou later haar bewussyn herwin, was Matthee reeds weg met dit wat hy uit haar huis gebuit het.

Volgens inligting, kon die vrou ná die voorval vanweë haar beserings 'n ruk lank nie praat nie. Matthee is later op dieselfde dag in Aslapark in verband met die voorval in hegtenis geneem. Please comment on fishmeal plant

The main take-home message following an information session and public meeting this week in the Mossel Bay Town Hall this week regarding the proposed plans to establish a fish meal and oil reduction plant on the Mossel Bay Harbour, is that all interested and affected parties must officially register to have an impactful say in the matter. During the information session, similar to the so-called town hall talks hosted in the recent past regarding the Moss Jazz Festival and the establishment of an aquaculture project, the public, after hearing what a panel of experts had to say, could raise their concerns and ask questions.

Public participation
Melissa Mackay, senior environmental consultant from Cape EAPrac in George, being the first to address the meeting on Wednesday, 20 November, thoroughly explained the environmental process and especially the role of public participation. Mackay reiterated that members of the community must contact her to register as an affected and interested party. The Draft Basic Assessment Report (DBAR) and a copy of the Comments and Responses Report for the proposed Afro Fishing Fishmeal and Fish Oil Reduction facility, is currently available for review and comment. The commenting period ends on 12 December.

The public can air their opinions until 12 December by contacting Mackay (044 874 0365 or mel@cape-eaprac.co.za). Mackay urged locals to familiarise themselves with the contents of the report. She said that it is available online at www.cape-eaprac.co.za, on CD or in hard copy. Hard copies are available at the public library also.

Odour addressed
An industry specialist, with "40 years' experience in the air pollution business", as chemical engineer Chris Albertyn, described

himself, took time to address some of the main concerns, being air quality and odour. He explained, at length, that odour abatement technology to be implemented at the proposed plant, the Regenerative Thermal Oxider (RTO) plant, is, although widely used in first world countries, was not yet in use anywhere in South Africa. Albertyn concluded his talk, saying that, according to his studies, the system can work, based on four principles: the processing of only fresh fish; the implementation of a properly designed extraction process; the preventative maintenance of RTO components, as well as skilled and trained operating and supervisory personnel working with the sophisticated RTO. Afro Fishing CEO, Deon van Zyl, elaborated on the proposed expansion, detailing the roll-out of the project, focusing on issues like job creation.

Concerns
Concerns raised during the question and answer session included air quality and odour control; increase in noise levels both during the construction period; as well as when the proposed plant is in full production. Participants also had queries about increase in traffic during construction phase and when in full operation after completion. Others expressed concern regarding the complaints process, should the plant become a nuisance later and what their course of action would be.

One of the participants complained that the "public participation process" was stalled by "long presentations", leaving too little time for open discussion. There was also an allegation of contradictory statements made on the night in comparison to the reports viewed, which was refuted by the experts. It was strongly suggested and supported that, a forum for ultimately monitoring the plant's operation be established. Most importantly,

the necessary Environmental Authorisation and Atmospheric Licence is needed before any further developments can take place. The Department of Environmental Affairs and Development Planning and the Garden Route District Municipality are the respective competent authorities to consider this application. * Also read comprehensive article supplied online at www.mosselbayadvertiser.com.

However, according to specialists, the impacts are likely to negligible to moderate.

First world technology

Technology not yet in use for the fishing industry anywhere in the country, but employed widely in first world countries, is proposed for the Afro Fishing fish meal processing plant. Odours will be managed using the odour abatement methods such as a Regenerative Thermal Oxider (RTO) plant. The RTO plant operates at maximum temperatures of 850C and will incinerate the particles that cause bad odours.

The only way to ensure zero industrial air pollution is to have zero industries. This, however, is not feasible and the best way then is to ensure that emissions do not impact negatively on the area. Everybody involved in this project, Afro Fishing, its environmental consultants, and the relevant authorities are highly conscious of the very sensitive nature of locating a fishmeal factory in the Mossel Bay harbour.

Everything is done to ensure that any emissions from the proposed plant will not impact negatively on the surrounding area, including the detection of odours. Is it possible the odorous emissions may occur? Yes, it is, but at such levels that it will not be detectable by the community.

Fresh fish

Afro Fishing will obtain fish from fishing boats that are allocated quotas for the industrial fish species. Pelagic fishing quotas are issued annually after analysis of the bi-annual biomass surveys also known as the Total Allowable Catch or TAC. The TAC determines the amount of fish that may be caught in any given year.

This TAC is updated during the year as the catch data is submitted. Certain species of pelagic fish are not suitable for human consumption for several reasons. For example, anchovy is small and oily and not conducive to filleting and processing for human consumption.

This type of fish is in abundance in SA waters and therefore harvested for reduction into fish meal and fish oil.

Fish meal is sold into the animal feed industry and fish oil mainly used for human consumption. The fish are caught at night because they mainly feed and shoal at night.

The use of Refrigerated Sea Water (RSW) and Chilled Sea Water (CSW) on the boats will ensure that the cold chain is maintained until the boats reach the harbour. This practice is currently in place for the existing cannery already so it will not be a new concept. On reaching the harbour, the holds are pumped out, which means the fish stay in the cold water and are not exposed to air which further slows any decomposition.

Fish that are kept cold take longer to decompose and produce trimethylamine (TMA) which is the odorous compound. Once the fish is inside the building, the ventilation system will direct all air via the RTO. TMA is destroyed at around 120C and the RTO will operate at up to 850C. The RTO unit will effectively incinerate any possible odoriferous odours.

The RTO technology is first world, state of the art and has as yet not been applied in SA. It is, however, used very successfully in many European cities and towns and in other parts of the world.

Indirect steam dryers

Concerns raised about the drying process of the fishmeal were also addressed. The offensive odours are not released during drying. The drying process actually stabilises the product and is the reason why fish meal can be stored safely for years once dried. Afro Fishing will install indirect steam dryers.

These are dryers with rotary discs heated by live steam and through the process of conduction, the discs heat the wet meal and evaporate off the excess water. Hot water vapour is removed from the dryer and used as the heat source in the liquids evaporation plant.

All the water vapour is condensed either in the evaporators or in the water scrubber following evaporation. So essentially air is not the transport medium to remove the water vapour from the dryers. Vacuum and blowers are the driving force.

Some air will be in the system and this is why the remaining air emitted from the drying process will be incinerated in the RTO unit.

Rotten fish

Afro Fishing was adamant that no rotten fish will be used by this factory. The delivery of rotten fish is not common to practice as it is not economically viable and skippers and crew will be dismissed for such practices. It does not happen anywhere in South Africa. It must also be borne in mind that the current fish canning plant operated by Afro Fishing produces products destined for human consumption.

Various control measures are already in place to ensure proper hygiene and health standards, including control over the quality of the fish currently being delivered to Afro Fishing. The fish oil that will be produced in the proposed fishmeal plant is also destined for human consumption, with the result that Afro Fishing will extend that current fresh fish quality control procedures to the fish delivered to the fishmeal plant, the main parameter is the temperature at which the fish is delivered to site.

According to the Air Quality Impact Assessment, the development of TMA is slowed when the product is kept cold (either by means of ice or refrigeration). Processing time within 24 hours is optimal for the quality of the final protein product, however, the studies have shown that TMA can be slowed for up to 100 hours when kept below 5C.

This is also current practice to ensure the quality of the sardines for the cannery which has to reach standards for human consumption. The further design of the facility with the RTO will significantly lower the risks of nuisance odours from the offloading and processing at the fishmeal facility.

Environment and effluent

An important aspect of a fish meal plant is that all the raw materials are processed to achieve maximum protein collection. There is therefore no offal. The existing cannery has some offal and this has been disposed of for the past 13 years without any threats to the environment or persons.

Discharge monitored

Afro Fishing has a Coastal Waters Discharge Permit from the Department of Environmental Affairs for the discharge of process water from the cannery. This discharge is monitored on a daily basis when the plant is in operation and will be amended to incorporate the cooling seawater for the proposed fishmeal facility.

Policing the odours

The Garden Route District Municipality will conduct a baseline odour screening at the harbour. This will provide a starting point to identify in the future, any potential problems and their origins.

The proposed facility will implement the Best Available Technology to ensure that their impact on the air quality at the port complies with all relevant requirements. Please also note that the other fishmeal facility to which you refer has recently had their license revoked for non-compliance.

Thus it is a priority of Afro Fishing to ensure that this facility is designed, built and operated at the highest standards.

Furthermore, fish meal is stored in polypropylene bags so the product is sealed. Fish meal anyhow is a stable product and does not deteriorate. There will be no offensive odours emitted from a warehouse.

No processing December/January holidays

Afro Fishing's proposed fishmeal plant is highly unlikely to operate 100% of the time as the availability of fish for processing is subject to seasonal variations. It is expected that the plant will run at full capacity for 4 to 8 weeks per year after which it will operate at reduced capacity and only whenever fresh fish is available.

Due to the fishing permitting system applied by the Government, no fish processing will be carried out from mid-December to mid-January.

Mossel Bay Waterfront

Concerns about the possible development of a waterfront at the harbour were also addressed. Industry, commercial and residentially zoned areas neighbour one another as defined by the local municipal precinct guidelines. Afro Fishing avers that they are not changing any of this.

With regards to the Mossel Bay Waterfront, the Quay 4 side of the harbour has been allocated for this activity. According to the Portnet and Municipal precinct plan, the Quay 1 side of the harbour remains allocated to fishing activities as this is a working harbour.

The new standard

In order to achieve top prices for fish meal and fish oil, fresh fish must be processed. This is the same driver for reduced odour emissions so it is in Afro Fishing's best interests to maintain standards 100% of the time. The RTO plant has a successful history in similar situations and Afro Fishing intends for this to become the new standard for fishmeal facilities.

The activity requires the necessary Environmental Authorisation (EA) and Atmospheric Emissions License (AEL) in order to commence and the Department of Environmental Affairs and Development Planning (DEA&DP) and Garden Route District Municipality (GRDM) are the respective competent authority to consider this application.

MOSSEL BAY NEWS - Southern Cape Fish Meal (SCFM) (Pty) Ltd, which owns the fish meal factory in Mossdustrya, has been ordered to stop all operations and to dispose of all existing stock at an approved landfill site.

The closest approved landfill site is Skoppies, about 35km from Mossel Bay towards Albertinia.

For years they have complained about the ongoing foul odour emanating from the plant.

The Garden Route District Municipality (GRDM) air quality manager refused the licence renewal application by SCFM in April 2018. At that time the GRDM ordered the owners to stop all operations linked to the listed activity.

Two different appeals

SCFM then appealed the GRDM decision and approached the High Court in Cape Town for interim relief.

The High Court interdict the SCFM obtained ordered the GRDM to allow the fish meal plant to operate until the appeal in terms of Section 62 of the Local Government Municipal Systems Act had been concluded. The municipal manager of the GRDM, Monde Stratu, was the appeal authority as the decision was taken by an official of the district municipality.

Recently this appeal was denied as, "based on the information and documents available to the appeal authority, it was unable to conclude that the upholding of the appeal would be consistent with the Air Quality Act and the Section 2 National Environmental Management Act (NEMA) principles," the GRDM communications department said.

Not end of the road

The owners of the SCFM may, however, approach the High Court to take the decision by the appeal authority on review. Until such a time the SCFM must cease all operations and a letter in this regard - a stop order - is being drafted.

The SCFM High Court order in 2018 indicated: "If the internal appeal is refused, the applicant is granted leave to supplement its founding papers, if regarded to be necessary, and to re-enrol the matter in order to obtain interim relief."

No further appeals in terms of Section 62 of the Systems Act will be allowed. The only other remedy is for SCFM to approach the High Court for interim relief.

What happens to waste

Afro Fishing CEO, Deon van Zyl, said the canning factory had been canning mainly imported cutlets. As a result they had not had much offal as there are no offcuts with imported cutlets.

"We are, however, preparing for the Port Elizabeth fishing season and our fishing vessel is already in PE, waiting for the weather to improve.

"So, when we start catching fresh fish we will have offcuts again. SCFM has indicated to us that it is unlikely to be able to process our offcuts so we are already preparing to transport offcuts to a similar offal processor in the Cape," Van Zyl said.

The *Deepsea Yantai* semi-sub rig, managed by Odjfell and sailing from Singapore, has moored off port limits in the bay to receive various services and change crew before proceeding to Las Palmas in the Canary Islands.

"Were it not for the efficient and constructive cooperation of members of staff of the Transnet National Ports

Authority (TNPA) and South African Maritime Safety Authority (SAMSA), effectively working with industry to attract the in-transit, East-West rig traffic to Mossel Bay, this historic moment of welcoming a rig of this magnitude to the bay would not have been possible," Afrishore CEO Shirley Schmidt said.

Girl (13) dies of overdose, friends hospitalised

A 13-year-old girl died in a Mossel Bay hospital on Sunday, 4 August, after she and two of her friends, reportedly the same age, took an overdose of medication.

The incident took place on Saturday evening at the family home of the girl who died, in the neighbourhood known as Albert Luthuli Village. According to information received, the girls were taken to hospital after they were found drugged. The two other victims were transferred to the George Provincial Hospital, after their condition deteriorated. One of the girls has been discharged from hospital and has returned

to school, according to information received. At the time of going to print, the third girl was still in hospital, in the intensive care unit.

The Department of Health was not at liberty to comment on the condition of the girls, because an inquest docket has been opened by the Da Gamaskop police and the victims are minors, therefore consent has to be obtained from the parents. According to the police, the girls all attended the same school in the JCC neighbourhood.

Further information regarding the incident and what led to the girls' actions, is still being assessed by police.

Port manager Shadrack Tshikalange said the Port of Mossel Bay was well-equipped to service the needs of large vessels such as the *Deepsea Yantai* despite being the smallest of TNPA's commercial ports on the South African coast.

"We commend the efforts of all roleplayers in ensuring the safe arrival of the *Deepsea Yantai*. TNPA values the opportunity to assist vessels of this nature and size in the future, which will earn us the trust of international organisations," Tshikalange said.

Exploration

Another vessel owned by the The Odfjell Group, *Deepsea Stavanger*, is expected to work on the next exploration drilling phase of the Brulpadda project on Block 11B/12B in the Outeniqua Basin situated off the coast of Mossel Bay, where energy giant, Total, discovered gas condensate earlier this year.

Block 11B/12B is located in the Outeniqua Basin, 175 kilometres off the coast. The

block covers an area of 19 000km² with water depths ranging from 200 to 1 800m.

"Mossel Bay is the only port that operates two offshore mooring points within port limits. TNPA's investment into the oil and gas industry ties into government's efforts to develop the 'oceans economy' through its Operation Phakisa programme," Tshikalange said.

Afrishore, as the facilitator, is excited about the return of the *Deepsea Stavanger*.

"It is expected that the *Deepsea Stavanger*, when she returns in 2020, will drill at least two exploration wells, with the option of further wells.

"It is expected the two exploration wells will take approximately nine to 12 months to complete.

"The true analysis of the exploration will happen during this next phase, when also the economic viability for the project will be assessed," Schmidt added. She said Afrishore had created an email address (vendors@afrishore.co.za) for local businesses to register and send their company profiles.

Staat roep die eerste getuies

Die verhoor van die 29-jarige Stephen Lekoro wat van die dubbele moord op die 72-jarige Tewie Human en sy 62-jarige vrou, Eurika verdink word, gaan steeds voort in die rondgaande hoër hof op Mosselbaai.

Die Humans is op 14 Junie 2016 wreed by hulle woning in Sandhoogtepad op Groot-Brakrivier vermoor. Lekoro het vir die Humans se rioolonderneming gewerk en het op Wolwedans gewoon. Sy vriend, die 27-jarige Thamsanqa Sishuba, ook 'n inwoner van Wolwedans, dien tans twee lewenslange vonnisse uit vir sy aandeel in die moord op die Humans. Sishuba het deurgaans tydens sy verhoor voor regter Robert Henney skuld ontken.

Lekoro ontken skuld op al vier aanklagte teen hom. Dit sluit in roof met verswarende omstandighede en moord. Hy voer aan hy was op die dag van die moord by die Humans se huis en het aan regter Mark Sher gesê hy en Tewie het na bewering 'n woordewisseling gehad omdat Lekoro die verkeerde tipe olie in 'n masjien gegooi het. Lekoro sê in sy pleitverduideliking dat Tewie hom na bewering vir die betrokke dag gevra het om 'n "ekstra hand" saam te bring en dat hy Sishuba saam na die huis geneem het. Hy beweer Tewie het hom tydens die woordewisseling by die motorhuis met die vuus geslaan waarna hy (Lekoro) Tewie eenkeer met 'n mes gesteek het wat hy op die werktoubank gekry het. Volgens sy pleitverduideliking het Sishuba toe vir Tewie met 'n kapmes aangerand waarna hy (Lekoro) gevlug het. Lekoro pak die skuld op Sishuba en beweer dat hy nie teenwoordig was tydens die moord en roof nie. Hy sê hy het gevlug omdat hy gewet was in die moeilikheid.

Foto's by vulstasie

Lekoro het kort na die moord na Lesotho gevlug en is in November 2018 in Bloemfontein in hegtenis geneem nadat hy teruggekeer het na Suid-Afrika. Foto's wat deur sekuriteitskameras by 'n vulstasie op Mosselbaai geneem is, is die afgelope week aan verskeie staatsgetuies gewys. Dit wys hoe Lekoro, wat deur die getuies op drie foto's geïdentifiseer is, 'n dag na die

moord, op 15 Junie, 2016 met bagasie deur die vulstasie stap en vir hom 'n buskaartjie koop. 'n Vriend van Lekoro het tydens die verhoor getuig dat hy Lekoro toevallig op die dag by die vulstasie raakgeloop het. Die getuie, wat 'n taxibestuurder is, het aan die hof gesê dat hy 'n bagasiesak vir Lekoro gedra het en dat Lekoro hom ingelig het dat hy na Bloemfontein gaan omdat sy broer glo siek was. Hy het aan adv. Lenro Badenhorst gesê dat Lekoro gespanne voorgekom het en dat hy baie geroek het. Hy het ook gesê Lekoro het by die vulstasie vir hom 'n mes gekoop wat hy oor sy kop kon trek. 'n Werkgewer van die busdiens het getuig dat sy 'n buskaartjie na Lesotho aan Lekoro verkoop het. Hy het glo kontant vir die kaartjie betaal.

Humans glo oor verdagte gestry

Die Humans se skoonseun ds Gerhard Pietersen het tydens sy getuies aan regter Sher gesê sy skoonouers het tydens die Aprilvakansie kort voor die moord gereed oor Lekoro gestry. Eurika het volgens Pietersen verskeie kere laat blyk dat sy nie gemaklik is met Lekoro nie en dat sy nie gehou het daarvan dat hy by die huis sou instap om sy kos in die mikrogolfoond warm te maak, sonder om aan die deur te klop nie. Volgens Pietersen het Tewie egter vir Lekoro opgekom. Die Humans is vier dae na die moord gevind nadat 'n jarelange vriendin, Doretha Wilson onraad vermoed het. Wilson het getuig dat die Humans nie hulle selfone geantwoord het nie en ook nie op boodskappe gereageer het nie. Sy is na die woning waar sy gesien het dat die Humans se twee honde, 'n Yorkie en 'n Staffordshire Terrier na die deur gehardloop het en die gordyn voor die deur opgelig het.

Die sekuriteitsmaatskappy, Suiderkruis en die Groot-Brakrivier-polisie is na die toneel ontbied. Eurika het op die egpaar se bed gelê en is met 'n mes gesteek. Tewie se liggaam is in die motorhuis gevind. Hy is minstens sewe keer met 'n kapmes aangeval en twee keer met 'n mes gesteek. 'n Tweede getuie van Absa-bank het getuig dat R14 000 om 20:20 dieselfde aand van die moord vanuit Tewie se bankrekening oorgeplaas is na 'n FNB-rekening. Die saak duur volgende week voort.

Is teenstand teen vismeelfabriek stank vir dank?

Mosselbaai se ekonomie gaan binnekort 'n groot hupstoot ontvang as die oprigting van 'n vismeel- en visoliefabriek die groenlig by die owerhede kry.

Afro Fishing, 'n plaaslike visfabriek wat sardyne inmaak, het buitelandse kapitaal van nagenoeg R350 miljoen bekom om hul bedrywighede in die hawegebied uit te brei. Daar word beplan om duisende tonne pelagiese visspesies, soos ansjovis en rooikappie (red-eye herring) by die aanleg te verwerk.



Dit sal seisoenale werk aan 'n bykomende 200 persone verskaf.

Nie almal is ewe opgewonde oor die projek nie en sowat 420 inwoners het 'n aanlyn petisie onderteken om teen die fabriek kassie te maak. Honderde mense het ook as belangstellende partye registreer; hulle wil weet watter impak die fabriek op dié skilderagtige kusdorp op die Tuinroete gaan hê en of daar permanent 'n stank oor die dorp gaan hang?

Deon van Zyl, Afro Fishing se besturende direkteur, sê die fabriek doen aansoek om 'n moderne aanleg op te rig wat die beste bewese praktyke en beskikbare tegnologie sal gebruik om die stank wat vismeelfabriek veroorsaak, te bestry.



Volgens 'n luggehalte-impakstudie wat verlede jaar vir die beoogde projek gedoen is, sal 'n sogenaamde nat skropper keer dat onaangename reuke in die atmosfeer losgelaat word. Volgens die studie sal daar, indien nodig, bykomend van regeneratiewe termiese oksidasietegnologie (RTO) gebruik gemaak word. Dit word reeds in die buiteland toegepas en die Mosselbaai-aanleg sal die eerste in Suid-Afrika wees waar dit gebruik word.

'n Span wat met die beplande projek te doen het, was onlangs by 'n vismeelfabriek in Peniche, Portugal waar RTO gebruik word en is vol lof vir die tegnologie.

Die oorgrote meerderheid van Mosselbaai se inwoners is egter steeds bekommerd dat die dorp dieselfde paadjie as Houtbaai en Gansbaai gaan loop. In Houtbaai was daar onlangs weer 'n vlag klagtes oor die vrot reuk wat van die plaaslike vismeelfabriek af kom en daar word nou selfs navorsing gedoen oor die impak wat slegte reuke op die mens se gesondheid kan hê. In Gansbaai het die reuk so erg geword dat die vismeelfabriek 'n paar jaar gelede verbied is om tydens vakansietye te werk omdat dit toeristegetalle negatief beïnvloed het.

Die Mosselbaai-gemeenskap vrees ook dat die fabriek die voorloper is vir die oprigting van 'n visplaas of sogenaamde akwakultuur, soos dié wat nou vir die Weskus beoog word. Visplase kan ernstige omgewingsrisiko's inhou en is ook

moeilik volhoubaar.

Die visse wat in die omatuurlike omstandighede aangehou word, word juis vismeel gevoer en met die fabriek in die hawe is akwakultuur dalk nou 'n stappie nader.



Elsa Wessels, die redakteur van die aanlyn nuusplatform Mosselbayontheline, sê in Suid-Afrika, soos in ander Afrika-lande, is die probleme erger omdat die betrokke owerhede selde die noodsaaklike maatreëls en wetgewing ten opsigte van water-, lug- en omgewingsbesoedeling toepas en afdwing.

“Gaan daar nimmereindigende hofsake op Mosselbaaiers wag soos wat nou in Saldanhabaai die geval is? En wie gaan kyk dat viskwotas gehandhaaf en die regte visspesies gevang word?” is van die vrae wat Wessels onlangs aan haar lesers gestel het.

Die 37-jarige Breed, 'n geoktrooieerde rekenmeester van beroep, dien sedert verlede jaar op die direksies van agt Suid-Afrikaanse maatskappye in die visbedryf. Volgens die aanlyn Fish Information Service (FIS) is Breed ook die besturende direkteur van die Angolese maatskappy African Selection Trust (AST). AST se webwerf sê die maatskappy se visie is om bestaande visfabrieke te restoureer en maksimale produksie te verkry wat werkverskafing en voedselsekuriteit in Angola sal bring.

AST het sedert 2017 sy vlerke in Suider-Afrika gesprei en besit 'n 60%-aandeel in die Namibiese maatskappy Seaower Pelagic Processing (Pty) Ltd. Die Namibiese staatsbeheerde Fishcor besit die ander 40%. Volgens die Namibiese dagblad, The Namibian, verteenwoordig Breed, die ekonoom Adriaan Louw en prokureur Marén de Klerk, AST op Seaower Pelagic se direksie.

Die amaBhungane-sentrum vir ondersoekende joernalistiek het in 2017 berig dat die Namibiese visindustrie woedend was omdat 'n internasionale belangegroep, verwysend na AST, gebaat het by die toekenning van 'n reuseviskwota aan die staatbeheersde Fishcor. Volgens die Daily Maverick behels die kwota 50 metrieke ton makriel (maasbankers) per jaar vir 15 jaar met 'n geskatte waarde van R120 miljoen per jaar.

Daar is destyds gesê dat ten minste vyf Namibiese maatskappye as vennote vir Fishcor kon kwaliseer, maar oor die hoof gesien is. Ten minste een, Bidvest Namibia, moes sy bedrywighede intussen staak en sowat 1 200 mense het hul werk verloor.

Seaower Pelagic het pas 'n visfabriek van nagenoeg R540 miljoen in Walvisbaai in gebruik geneem. Die aanleg kan soveel as 600 ton makriel (maasbankers) per dag verwerk.

As Johannes Breed by AST se bedrywighede in beide Angola en Namibië betrokke is, dan is die logiese vraag of AST ook die belegger agter die R350 miljoen-inspuiting in Mosselbaai se Afro Fishing is?

Wat is AST se aandeel in die ander plaaslike vismaatskappye waar Breed ook op die direksie dien? En wat beteken dit alles vir die plaaslike visbedryf?

Deon van Zyl, Afro Fishing se besturende direkteur, ontken dat die maatskappy 'n filiaal van AST is en was slegs bereid om te sê dat die geld vir die Mosselbaai vismeelfabriek 'n belegging uit die buiteland is wat privaat bekom is.

Maroela Media se navorsing wys dat Norfund, die Noorweegse Beleggingsfonds vir Ontwikkelende Lande, in 2010 'n privaat aandelefonds in Angola begin het en dat verskeie Europese banke en ontwikkelingsfondse intussen by Norfund aangesluit het.

Die fonds word deur Angola Capital Partners (ACP) bestuur en die ACP-webwerf verwys na ses verkose Angolese maatskappye, waaronder African Selection Trust, waarin daar in die laaste paar jaar miljarde belê is vir uitbreiding.

In Angola het dit vooruitgang vir gemeenskappe gebring deur werkgeleenthede te skep en die plaaslike bevolking te bemagtig. Maar in Namibië het meer as 'n duisend mense, na bewering, hul werk verloor, aldus koerantberigte. Die beplande vismeel- en olieproduksie is uitsluitlik vir die uitvoermark bedoel waar dit as 'n bestanddeel van dierevoer gebruik word. Sowat vier kilogram vis is nodig om een kilogram vismeel te vervaardig.

Van Zyl sê Afro Fishing het nie self viskwotas nie, maar koop pelagiese vis aan by ondernemings wat wel kwotaregte het.

Dis eintlik ironies hoe die visbedryf werk, want Afro Fishing se bestaande inmaakaanleg het sedert 2016 duisende ton gevriesde sardyne uit Marokko ingevoer om steeds aan die plaaslike markvraag te voldoen nadat kwotas gesny is.

Maar wat van Mosselbaaiers se vrese oor visplase in die see en op land?

En al die omgewingsprobleme wat daarmee kan saamkom? Kenners is dit eens dat die kans skraal is dat Afro Fishing ook 'n visplaas sal begin omdat vismeel en visolie reeds wêreldwyd in groot aanvraag is en toppryse behaal.

Tog is dit nie te vergesog om te glo dat akwakultuur dalk wel na Mosselbaai op pad is nie. Johannes Breed se pa, Jannie, was vir baie jare die besturende direkteur van Ridge Solutions Aquaculture in Angola waar garnale op groot skaal vir die uitvoermark verbou is.

Dan is daar ook al gesê dat Mosselbaai beskou word as dié mees geskikte plek in Suid-Afrika om 'n visplaas te begin waar geelstert verbou kan word. En net verlede jaar was daar 'n omstrede inligtingsessie oor akwakultuur wat deur die Mosselbaai-munisipaliteit aangebied is.

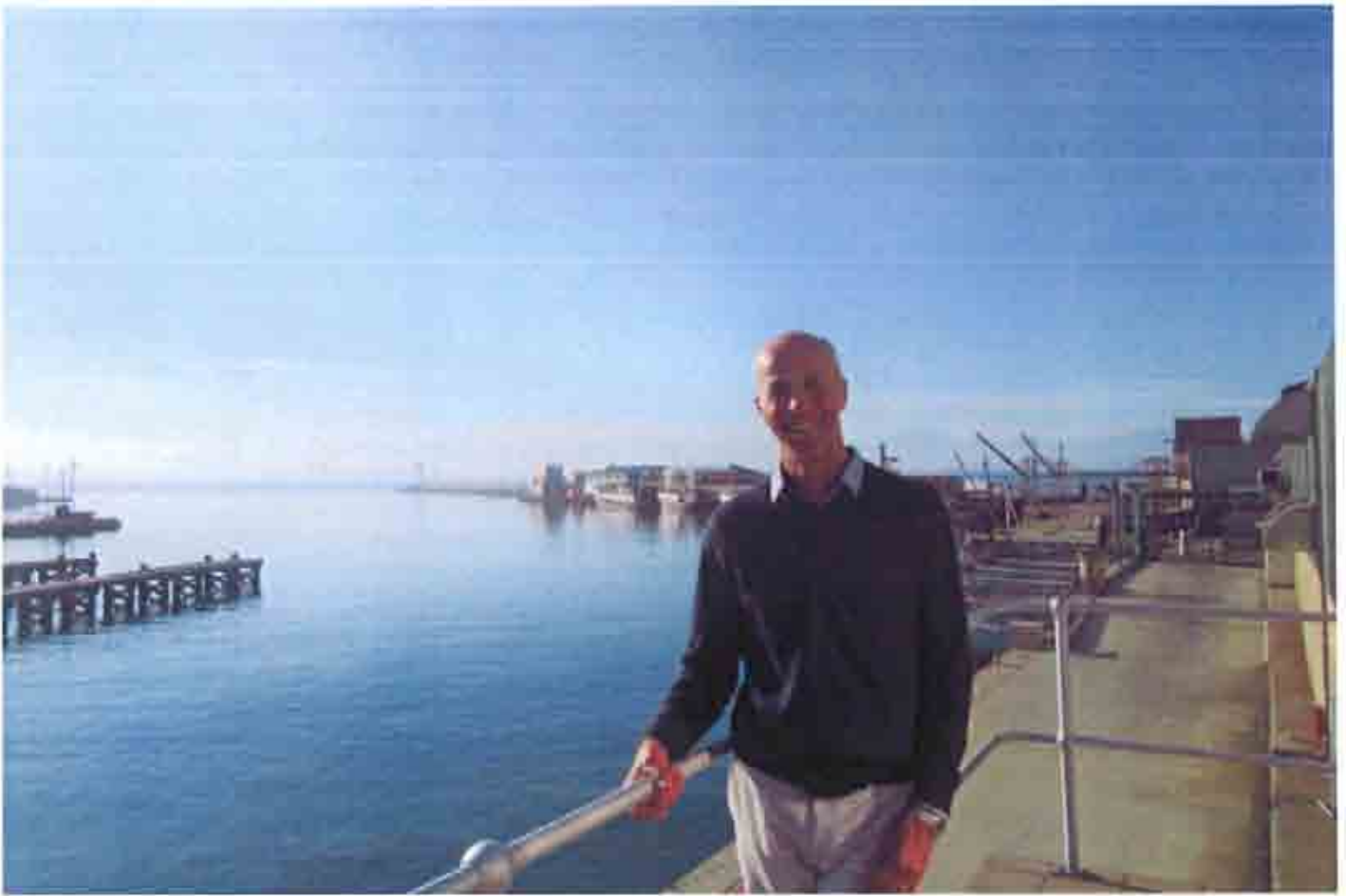


Fish Meal Plant - the A-Z of what Afro Fishing's plans are

Afro Fishing's application to add a fish meal and oil manufacturing plant to its sardine canning operation on Quay 1 of the Mossel Bay harbour, has caused quite a stir and public outrage - not in the least due to the way it was initially only announced in an unobtrusive municipal notice on a back page of the local community paper where very few people saw it.

While the environmental impact studies and public participation process is still ongoing, we spoke to Afro Fishing's managing director Deon van Zyl, to find out more about his plans.

Deon is a qualified chemical engineer with an MBA (University of Cape Town). From Deon's LinkedIn profile, he has mostly worked in the food sector of which more than 20 years was in the fishing and seafood industry.

He returned to South Africa in January 2018 and was recently appointed MD of Afro Fishing (Pty) Ltd in Mossel Bay.



Fish meal plants historically have a bad reputation - not only due to the air pollution and repellent odours, but also water pollution from the continuous dumping of thousands of litres of bloody waste and effluent into the sea. Overfishing is another major concern - especially these days when it is alleged that up to 90% of edible wild fish are indiscriminately caught to supply in the insatiable fishmeal market for animal feed and the aquaculture industry. It is alleged that millions of tons of fish are being harvested from the wild every year to produce fishmeal and fish oil to feed caged fish reared in underwater factory farms, which hugely increases the pressure on already depleted edible wild fish stock. Fish meal plants is also a water-intensive industry putting more strain on drought-ridden areas.

In a pledge for transparency and to dismiss fears that the fish meal factory is part of a ploy to establish the groundwork for open sea fish farming, we asked Deon the following questions:

1. After your extensive travels and experience, what made you choose Mossel Bay specifically for such a notorious endeavour? Especially in the light of all the ongoing court cases against fish meal factories and aquaculture sea farms in other harbour towns in the Western Cape?

DvZ - Afro Fishing (Pty) Ltd (AF) recently won the bid to lease the old I&J site adjacent to its canning operation with the strategy to grow the business into other related activities. The proposed fish meal and oil facility is a natural extension to the existing cannery as the same fishing vessels are used and both operations are in the small pelagic fishing sector. Yes, we are aware that fish meal plants have in the past generated negative publicity. AF is, however, requesting authorisation for a modern facility, using the best-proven practices and the best odour management system available.

2. Who are the other directors of Afro Fishing and what experience do they have in fish meal plants?

DvZ - There are two other SA directors, Shemara Daniels and Johannes Augustinus Breed. They have extensive fishing industry experience plus they own freezing facilities, fish meal plants, fishing vessels and canneries in Angola and Namibia.

3. Afro Fishing has been operating as a sardine cannery operation in Mossel Bay since 2007. Since 2016, it was forced to import thousands of tons of Moroccan sardines in order to meet market demands. This was mainly due to a combination of factors - a drastic reduction in the national total allowable catch (TAC) for sardines, shifting shoaling patterns caused by climate change and poor recruitment (number of fish surviving to enter the fishery or to some life-history stage such as settlement or maturity). Has the local situation re sardine stock changed since and how will an additional fish meal and oil manufacturing plant benefit the company and / or the town?

DvZ - The entire local canned pilchard industry does rely currently on a mix of freshly caught pilchards and frozen imported pilchards. Currently, the industry is going through a period of low TACs for pilchards. The biomass (total weight of sardine in the SA sea) as observed during annual hydro-acoustic surveys has reduced considerably. This is, however, a cyclical fishery and the biomass of pelagic species varies considerably over time due to many factors. Therefore, this fishing sector is regarded as a 'boom or bust' fishery. The main reason is that the species is short-lived and hence dependent mainly on the level of recruitment. * *Recruitment means the count of eggs and larvae produced by the current stock and that will mature to become adults.* This recruitment requires many environmental processes to come together to grow biomass. The Fisheries Scientists and DAFF have relatively conservative models to determine the annual TAC. The primary factors influencing small pelagic biomass levels are recruitment, predation and climate-related factors.

A fish meal and oil plant will benefit as it will diversify AF into other species, namely anchovy and red-eye herring and into other products and markets. The erection of a cold store will allow AF to process *sardinella*, another pelagic species fished in Southern Africa waters. Currently, AF only cans pilchards making the company vulnerable to the nuances of the pilchard biomass and a single product. Canning *sardinella* will also open other products and markets.

4. What water will be used in the water-intensive industry - potable municipal water, seawater or will a desalination plant have to be used?

DvZ - This is not a potable water-intensive industry. No potable water is added to the products. Water will be required for the boilers, but we will also be installing condensate recovery units to reduce the boiler water consumption. Some potable water is also used for cleaning. The expansion will however not use more water than the previous user of this site used.

Seawater is used for cooling. This is where the large volumes are. This cooling seawater is however returned to sea untainted.

5. It is claimed that ten kg of edible wild fish is used to produce one kg of fish meal for animal food and to feed caged/farmed fish. Isn't that defying the purpose and contributing to the depletion of healthy wild fish species around

the globe to fund a false economy that actually causes food scarcity under the noble banner of the World Food Programme?

DvZ - The conversion factor in South Africa is closer to 4kg of industrial fish to produce one kg of fish meal. There is however also fish oil produced for other markets. The fish meal product is mixed with other ingredients to produce agriculture or aquaculture feed. It is important to note that only a fraction of a short-life species is harvested for this purpose. South Africa has a good record at fisheries management and no species has ever been depleted due to overfishing.

The biomass and distribution of pelagic species are assessed bi-annually using hydro-acoustic surveys. These surveys have been conducted without interruption for 35 years. This comprises a summer adult biomass survey and a winter recruit survey. This plus ongoing research of the small pelagic fisheries assist the department to develop, manage and revise the sector Operational Management Procedures (OMP). Data on catch statistics including landed mass, species composition, and catch position and date are also obtained by DAFF for the pelagic fishery.

6. What fish species and how much will be used in the fish meal and oil manufacturing plant and how will it affect the food chain in Mossel Bay's prolific waters where the marine Big Five - whales, sharks, dolphins, seals and penguins - are still abundant? How can be assured that all other fish species are not being caught indiscriminately as well for fish meal and oil?

DvZ - The intention is to harvest anchovy and red-eye herring for the fish meal and oil plant. The biomass of both these species is currently healthy. Once again only a fraction of the biomass will be allocated to catch as per the OMP's referred to in the previous question. The TAC's are established at levels that have a negligible impact on your big five or other eco-systems.

The quantities will depend on the TAC allocated by DAFF and then the portion thereof AF is able to secure.

Yes, it is correct that sardines play an important role in regulating ecosystem functioning. It is for this reason that DAFF has closed off fishing areas with the aim of eliminating the impact on for example African penguin and Cape gannet breeding colonies.

7. What are the fish meal and fish oil used for and to where and how will it be exported from Mossel Bay's harbour?

DvZ - Fish meal is one of the ingredients blended with other ingredients to produce various animal and aquaculture feeds and hence controlled by the Department of Agriculture. Fish oil is mainly used as an Omega-3 source for various foodstuffs and health foods.

Both the fish meal and fish oil are packaged in containers and shipped to export customers. Initially, the containers will be road transported to PE for export. The Port of Mossel bay does have plans to become an import/export port. When that happens exports will be direct from the Mossel Bay harbour precinct.

8. What will happen to the waste/effluent of the plant and how will it be treated not to cause further pollution to the ocean?

DvZ - There is no waste from a fish meal and oil plant. All the landed fish and blood water are reduced into the finished product.

9. How many people are currently employed full-time at Afro Fishing and how many extra people will be employed full-time for the fish meal and oil plant? How can be made sure that local people get preference to outsiders flocking to Mossel Bay as soon as they hear of another industry?

DvZ - Currently, AF employs 340 staff when we are running two shifts. The expansion plan is expected to increase the total to 500 plus.

AF has a policy of employing locally where possible. The intention is to also recruit locally during the construction phase as was done when the cannery was built.

10. Mossel Bay is traditionally a tourist town with tourism being the main/only? source of income to most local businesses. People fear the negative impacts of such an industry in close proximity to restaurants, guest houses and other tourist attractions will have a severely negative effect on their businesses and cause a much greater loss of jobs than the few hundred jobs that a fish meal plant can supply - again defying the purpose of job creation. False or true?

DvZ - Mossel Bay is not only a tourist town. Mossel Bay has a working harbour, a thriving fishing industry, tourism industry, a gas refinery, gas platform supporting industry, an agriculture sector and many other industries. The drive through Voorbaai certainly does not depict a town that is only based on tourism. The Municipal Precinct Plan and the Transnet National Ports Plan cater for all these industries and opportunities with the aim of maintaining sustainable economic growth and employment opportunities in all sectors, not just tourism.

11. Air pollution: On certain days (depending on the wind direction), unpleasant smells from the cannery have been offending people in neighbouring buildings for years despite strict control. How will the latest RTO technology and equipment ensure that even worse odours do not occasionally occur?

DvZ - There has not been a single complaint with the current canning operation and AF has always been regarded as a compliant and nuisance free neighbour. I can assure you all odours emitted comply with legislative thresholds. AF also burn 'low sulphur fuel oil' in our boilers precisely to reduce certain emission levels.

Please also note that we are a fishing operation located in the part of the harbour allocated and zoned for fishing and industrial activity.

12. What are the overall benefits of such a fish meal and oil manufacturing plant to Mossel Bay?

DvZ - Currently the port is operating at less than 20% of its capacity. The site designated for this project has been dormant for almost ten years. This project will develop this site, provide added harbour activity, contribute towards the Mossel Bay economy and most importantly provide much-needed employment opportunities.

13. What are the worst-case scenarios to the environment?

DvZ - There is no worst-case scenario. There has never been an environmental disaster linked to a fish meal and oil facility. The intention is to expand and grow AF in a sustainable and environmentally compliant manner. There will be no flouting of regulations and environmental laws.

14. On a more personal note: Are you a family man and do you plan to settle in Mossel Bay?

DvZ - Yes, my wife Yvette and I have settled in Mossel Bay. Yvette is an architect. We have bought a property in the area. For this reason, I also want to build a facility that contributes to the economy of Mossel Bay and that does not become a nuisance.

Best practices, latest technology investigated

This will be a first for Mossel Bay and for South Africa. Technology not in use yet for the fishing industry anywhere in the country, but employed widely in first world countries, is proposed for the Afro Fishing fish meal processing plant that is planned for the old I&J site in the Mossel Bay harbour.

"Because it is starting from scratch, Afro Fishing can use the best available technology on the market to design and put in place - according to best practices - all the safeguards afforded by this latest technology to prevent any odours or other nuisance," says environmentalist Melissa Mackay.

Effect on air quality

The effective use of regenerative thermal oxidisers (RTO) at fish meal plants and their effect on air quality were investigated by a technical team who visited Portugal and Spain last week. The RTO is widely used in Europe. Internationally, test results indicate that technology such as the RTO prevents air quality problems associated with organic compounds.

"According to the Environmental Protection Agency of the USA, thermal treatment is the best way to destroy odours at fish meal plants," chemical engineer Chris Albertyn said.

He said the RTO oxidises the odorous compounds at 800 to 850 degrees Celsius. Afro Fishing chief executive officer Deon van Zyl, a qualified chemical engineer with an MBA (University of Cape Town), led a technical team on a visit to two fish meal plants in Europe, where the best available technology is used in the processing of fish meal according to European Union standards.

Technology and best practice

The purpose of the visit was to investigate best practices at the plants, where the said technology has been employed for several years and to note how it impacts the ambient air and odours usually associated with such plants. The team also assessed the operating reliability of RTO processes.

Van Zyl told the *Mossel Bay Advertiser*, which accompanied the technical team on the visit, that he is totally aware of the concerns raised by residents about odours and possible pollution.

"We have only just started the environmental impact assessment and authorisation process, which involves various aspects and consultation with the public

prior to any final decision being made on the development," Van Zyl emphasised.

The environmental impact studies, he says, will be used to assess the potential impact of Afro Fishing's proposed expansion and development into fish meal, both on the physical environment and on the social environment. The results of the extensive impact assessment will assist the relevant authorities in their decision making.

Similar to Mossel Bay

Two towns with characteristics very similar to Mossel Bay were visited. In Spain, a plant close to Tarifa was visited. Tarifa is a small, historic town in the province of Cadiz, Andalusia, on the southernmost point of mainland Europe. Its popularity as a holiday destination has increased in recent years, mainly due to its position as Europe's most significant windsurfing and kitesurfing destination. In Portugal, the factory Fabrica de Farinhas Oleos de Peixe, located in the working harbour of Peniche, was visited. Peniche is a seaside village located in the Oeste sub-region. It is a popular beach destination, known among surfers as "surf central" and home to annual international surfing competitions hosted on a beach directly adjacent to the fish meal plant.

Both towns are highly dependant on the oceans economy and tourism for job creation and economic sustainability.

European Union standards

Environmentalist Melissa Mackay said: "What was very interesting for me, especially at the Peniche plant, was that the owners, Rui and Joao Dias, were extremely open about the problems they had experienced with odours until they implemented the RTO system some ten years ago.

"Old technology had been a problem. The factory now operates with all the relevant licencing from the authorities - of which we were given copies - according to very strict emission standards of the European Union (EU) for odours.

"South African legislation is similar; our

laws have taken a lot of information and limited thresholds from EU standards," Mackay said.

Pungent odour

"South Africa has no set limits for a compound called Trimethylamine (TMA) - a pungent, fishy, ammonia-like odour. It was important for me to note that the RTO is able to reduce the TMA emissions. TMA emissions are not usually measured at fishmeal plants. However, special preparations were made by one of the possible suppliers of the technology, Haarslev to have TMA measured in Peniche on 12 June."

Fresh fish

As opposed to the plants visited, Mackay said Afro Fishing would use predominantly fresh fish for their fish meal processing plant, further limiting possible odours.

Credentials

Apart from Van Zyl, the technical team consisted of Cape Environmental Assessment Practitioners (Pty) Ltd (Cape EAPrac) senior environmental consultant Melissa Mackay (Practitioner / GIS / ECO) and chemical engineer Chris Albertyn, who is registered as a Professional Engineer (PrEng) by the Engineering Council of South Africa (ECSA) and a Chartered Engineer (CEng) by the Engineering Council in the UK, and is certified as a Qualified Environmental Professional (QEP) under the Institute of Professional Environmental Practice in the USA, a certification that is awarded for multidisciplinary environmental management expertise. The Qualified Environmental Professional (QEP) certification was initiated in the USA with the aim of improving environmental management in general and is an international programme. *Mossel Bay Advertiser* news editor Nickey le Roux accompanied the team on its visit.

Afro Fishing responds regarding concerns

Deon van Zyl, CEO Afro Fishing, writes:
On behalf of Afro Fishing I would like to take this opportunity to respond to some of the negative publicity we have been receiving relating to our expansion plans. Firstly, we must emphasise that we have only just started the environmental authorisation process which involves various aspects and consultation with the public before any decision is made to allow the development to start.

We have appointed Cape EAPrac as the independent environmental consultants to manage the process and we have already initiated several impact assessment studies (e.g. Air Quality Impact Assessment, Socio-Economic Impact Assessment). These impact studies will be used to assess the impact of the proposal on both the physical environment and the social environment and to assist the competent authorities in their decision making. This will ensure that the community concerns associated with the proposal will be addressed in these impact studies.

I would, therefore, like to indicate that there is no hidden agenda on behalf of Afro Fishing. Afro Fishing has been accused of many things during the last few weeks but all we are doing is following a legal procedure step by step.

Secondly, we are a fishing business wanting to expand in fishing related activities within the area designated by the Mossel Bay Development Framework and the TNPA Port of Mossel Bay Framework plans for the fishing industry.

I previously worked in Hout Bay Harbour and saw first-hand how a community collapsed when I&J and Sea Harvest divested from the area.

Until today Hout Bay harbour has never recovered, with resultant poaching and unrest ongoing. We are wanting to rejuvenate two redundant commercial fishing sites within the Mossel Bay harbour. This should be positive for Mossel Bay; the harbour is a working harbour after all.

With regards to the fish meal and oil rendering facility and the emission of odours, our intention is not to install a facility that will negatively affect ambient air quality or have, for example, a negative effect on tourism.

This will not be sustainable.

This is not going to be an installation similar to what has happened in the past in South Africa. We will apply best practices as are required by law and will ensure that emissions meet threshold limits.

We will be discussing the detailed process flowsheet with interested and affected parties once the formal Environmental Impact Assessment public participation process starts.

At this stage, however, we would like to inform all that the concept involves the installation of an RTO unit.

This is a re-generative thermal oxidiser that will remove odours and which has been successfully applied in numerous first world countries. The RTO is a fundamental departure from traditional fishmeal facilities as we know them in South Africa.

Since inception Afro Fishing has been good for Mossel Bay. We intend keeping it that way.

We appreciate the inputs received and in order to be provided with the correct information, we strongly advise that you participate in the EIA process by registering as Interested and Affected Parties. Toerisme is die ruggraat van die Mosselbaaise ekonomie, en weens die natuurskoon, netheid en aangename klimaat van Mosselbaai, lok die dorp jaarliks duisende toeriste. Die dorp se vernaamste toeriste-atraksies asook hotelle is binne 'n paar honderd meter geleë van waar die fabriek opgerig gaan word. Die oprigting van die fabriek sal doodgewoon roekeloos en onverantwoordelik wees, en kan tot die verlies van talle werkgeleenthede in die plaaslike toerismebedryf lei.

Proposed fish meal plant downright reckless

Monday this week was the last day to register as an interested and affected party for the environmental authorisation process for the establishment of a fish meal and oil reduction plant in the Mossel Bay harbour. It is hoped that all property and business owners in the old CBD area of Mossel Bay will object *en masse* to the establishment of such a plant, which could have a devastating effect on Mossel Bay's tourism economy as well as the CBD and surrounding property

markets. According to the specialist Air Quality Impact Assessment which has been prepared for the project "it is generally accepted that odours will always be generated during fish meal production processes". The report also refers to it as "offensive odours". Although the report suggests that certain mitigating measures could be implemented, there can be no guarantee that the area, which houses prime tourist attractions such as the Dias Museum

Complex, the Santos Blue Flag beach, the Goods Shed Flea Market, the Point area and some of Mossel Bay's best restaurants and accommodation facilities, will not be engulfed permanently by the stench of rotten fish. It would be downright reckless if the local and other authorities allow the project, which will seriously affect the value of hundreds of residential properties within a radius of two kilometres of the plant, as well as result in many job losses in the tourism industry, to proceed.

Port an 'enabler' for Brulpadda

Mossel Bay may be the smallest of Transnet National Ports Authority's (TNPA's) commercial ports on the South African coast, yet it is the only one that operates two offshore mooring points within port limits, port manager Shadrack Tshikalange said at a meeting last week, where economic growth opportunities in the area were discussed by various stakeholders.

French oil and gas company Total recently announced the significant discovery of gas condensate off Mossel Bay.

Gas condensate is predominantly gas but

"There is a five to six year horizon to

get ready for production, yet the question

remains whether Total will be interested in using existing infrastructure," PetroSA operations manager Michael Nene warned.

He said Total would have to be convinced of the ease of use of local infrastructure over that of Cape Town or Port Elizabeth.

He emphasised that the Mossel Bay port

should also be marketed as an enabler for the fruition of the Brulpadda project, considering its proximity to Cape Town and Port Elizabeth, and taking into account the infrastructure of the region, such as the

nearby George Airport.

Garden Route District municipal manager Monde Stratu reiterated that the port of Mossel Bay forms part of the district municipality integrated development plan.

"The district municipality is excited about the prospects of the Brulpadda project."

The current depth of the existing harbour and proposed alterations to the current infrastructure were discussed.

Work resumes on harbour administration building

A new contractor, RUWACON, has been appointed by Transnet National Ports Authority (TNPA) to conclude the extension of the Port of Mossel Bay administration building.

The project, valued at approximately R16 000 000, is expected to be completed during the second half of 2020.

Construction initially began in September 2015 but stalled due to performance issues with the original contractor. The previous contract was cancelled and TNPA then proceeded with an open tender process to appoint a new contractor, following which, RUWACON was appointed.

Port Manager, Shadrack Tshikalange, said the extension was essential as the port had continued to employ more people in line with Transnet's Market Demand Strategy (MDS), which aimed to create jobs and drive economic growth.

"The extension and modifications to the building aim to provide port users with a

more public friendly building, more efficient service and improved building access, especially for the physically disadvantaged. It will accommodate 56 staff members once complete," he said.

"Additionally, we anticipate that 30 jobs will be created as a result from this project and this is significant as it contributes Operation Phakisa's mandate of job creation."

The extension entails additional office space to cater for new employees. An entrance foyer, which was not previously part of the administration building, will be added to accommodate clientele. A new glass lift will also be installed in the building to cater for people with physical disabilities.

Tshikalange said port access during construction will be affected.

"The road linking SEAVUNA and the Civil Workshop, which passes by the administration building, will have limited access during the project's duration. People

and vehicles entering the Port towards Vincent Jetty and the SEAVUNA area will be required to enter the Port through Gate 1," he said.

Tshikalange said the management and employees of the Port of Mossel Bay were looking forward to having the building completed by the end of next year.

Brulpadda: 'Support guaranteed'

Mossel Bay is ideally situated to offer offshore facilities and services to global energy giant Total following the significant gas condensate discovery on the Brulpadda prospects, located on Block 11B/12B in the Oudeniqua Basin, 175 kilometres off the coast.

However, Total E&P South Africa logistics manager Patrick Flévet, although optimistic, cautioned that a lot of exploration work still has to be done to ensure the viability of the source.

He said the condensate found in recent explorations is currently being examined in

France.

but we are the best. Size may also hamper service delivery, yet the Mossel Bay Municipality's employees are driven and well known for going the extra mile," Adv Gillioeme said.

He added that there are decided advantages to not being such a large town, as immediate service delivery can be guaranteed.

"Mossel Bay can offer 18% spare capacity of electricity, and unlike other municipalities, does not owe Eskom any outstanding debt.

"Furthermore, municipal services such as the provision of water can be guaranteed, considering the town boasts the largest desalination plant in Africa."

Advocate Gillioeme highlighted the excellent healthcare facilities in town,

saying the Life Bay View Hospital has consistently ranked among the top three private hospitals in the country for a number of consecutive years. He also mentioned the stable political landscape and said it augurs well for future investment.

Speaking on behalf of businesses in Mossel Bay, Shirley Schmidt, a well known business woman who has been closely involved with Total during the Brulpadda exploration phase, said opportunities would extend to the rest of the Southern Cape.

She cautioned that Mossel Bay businesses should embrace the opportunities without creating false expectations of job creation in the short term.

"All services in town should be geared towards service delivery; businesses should embrace a state of readiness considering the very high service delivery standards that will be expected."

She added that Mossel Bay is the only oil/gas town in South Africa and therefore uniquely positioned to capitalise on the opportunities.

Mossel Bay port manager Shadrack Tshikalange said there never before had been such a good challenge for the port to grow as an anchor of economic development and growth for the town.

"We would like to thank Total for using the Port of Mossel Bay during the exploration phase," he said. "We are open for business."

Work together

He called for a high level meeting with the executive management of TNPA to explore opportunities, requirements and needs.

"In Mossel Bay we work together; you will never go wrong when doing business with

this city," Tshikalange said.

Several opportunities exist for the Mossel

Bay airfield to be used more extensively, Henk van Wyk of the Aeroclub said. He elaborated on planned extensions to the airfield and said several surveys are being conducted to make it a reality. "The length of the runway can be extended."

A similar message was conveyed by George Airport manager Brenda Vorster. She explained several expansion programmes and said plans were to extend the footprint of the airport to other local airports and even international destinations.

Mossel Bay. During this particular exploration exercise, the various supply vessels made regular use of our berths.

"Our port is also able to provide a craft service to do crew changes and stores delivery offshore," said Tshikalange.

Closest to Cape Town

Mossel Bay is the smallest of the commercial ports on the South African coast. It is the only South African port that operates two offshore mooring points within port limits. It is also home to one of only a few gas-to-liquids refineries around the world, though the port deals mostly with the fishing industry.

The Brulpadda find contains condensates - a kind of light crude oil - which only PetroSA's Mossel Bay refinery can process.

Total's drilling campaign commenced in November 2018 and is due to be completed in March. It involves one rig and a fleet of four vessels being managed by AfriShore Shipping Pty Ltd on behalf of Total.

Vessels

The Deepsea Stavanger rig worked about 180km offshore of Mossel Bay. Supply vessels that worked alongside the Deepsea Stavanger are the *Bourbon Diamond*, *Pacific Dragon*, the *Far Starling* and the *Normand Ranger*.

The *Bourbon Diamond* is a large platform supply vessel for deepwater operations and has a deadweight of 4 850 tons and break horsepower (BHP) of 9 790. The vessel has been working on the Total project from the onset transporting supplies between the Deepsea Stavanger and the port.

The *Pacific Dragon*, belonging to Swire Pacific Offshore, joined the project halfway through the drilling programme and has only visited the Port of Mossel Bay once as she has a deeper draught and is tide dependant.

She was mainly used to uplift bunkers in Cape Town and discharge to the Deepsea Stavanger. She has a bollard pull of 220-238 tonnes, BHP of 17 614 and deadweight of 4542.84 tonnes.

Solstadt Offshore ASA has two vessels involved, namely the *Far Starling*, with a deadweight of 4000mt and BHP of 9996, and the *Normand Ranger*, with a deadweight of 3954mt and BHP of

In its media statement Total said: "Following the success of Brulpadda and confirmation of the play potential, Total and its partners plan to acquire 3D seismic this year, followed by up to four exploration wells on this license.

The Block 11B/12B covers an area of 19 000 square kilometers, with water depths ranging from 200 to 1 800 meters, and is operated by Total with a 45% working interest, alongside Qatar Petroleum (25%), CNR international (20%) and Main Street, a South African consortium (10%)."

Writing for *The Conversation*, Robert Scholes, a Systems Ecologist at the Global Change Institute (GCI), University of the Witwatersrand and Rod Crompton, adjunct professor, African Energy Leadership Centre, Wits Business School, University of the Witwatersrand, said: "The government's energy policy and its Gas Utilisation Master

Plan agree that South Africa could usefully increase the amount of natural gas in the mix. It wants to diversify away from coal and imported crude oil."

They added: "Since there's a captive market nearby, Total - an international, for profit company that will charge a market-related price for its gas - will almost certainly first try to sell it locally, rather than incur the cost of transporting it elsewhere. The most likely first candidates will be the PetroSA gas-to-liquids plant and the Gourikwa (diesel) power station near Mossel Bay."

In its own statement the South African government said: "Cabinet has lauded the offshore discovery of gas condensate by oil company Total that could contain one billion barrels of resources, which will significantly boost the country's oil and gas supplies." It said the gas discovery ties into government's efforts to develop the "ocean economy" through the second phase of its Operation Phakisa. Government's Operation Phakisa: Oceans Economy programme is at work in Mossel Bay, where a slipway upgrade is in the pipeline and the port has entered into a Service Level Agreement with PetroSA to provide SETA accredited apprenticeship training to 15 youth from previously disadvantaged communities in Mossel Bay.

Allegations of animal cruelty investigated by police

The Da Gamskop police are investigating two cases of animal cruelty.

Two former staff members of the Garden Route SPCA have been accused of a criminal offence in terms of the Animal Protection Act after a dog owner brought his boerboel to the branch to be euthanased.

The dog was brought in by its owner because of its aggression towards people. According to the police, the two former staff members covered the dog with a blanket in an attempt to restrain the dog, for their own protection. It is alleged that in the process of restraining the dog, it died of asphyxiation. The incident took place on 17 January.

In another case investigated, a man from the Asazani settlement in the ICC residential area, KwaNonqaba, allegedly killed a dog after not finding his earphones. The incident took place on 21 February when the suspect arrived at a neighbour's home, looking for his earphones.

The woman living at the premises, who is also the complainant in the matter, replied that the dog often played with such items. Upon hearing this, the man apparently grabbed hold of the dog by its leg and slammed it into the ground, killing it instantly.

Both cases are being investigated by Wc Deon Louw.

Plans for fish meal factory in harbour

Mossel Bay residents have reacted with concern at the news that Afro Fishing (Pty) Ltd, the owner of the canning factory in the harbour, is planning to establish a fish meal factory on the old I&J premises.

There are also plans to expand the canning factory to accommodate red herring, anchovy and other fish catches.

An opportunity allowing the public, neighbouring property owners and key stakeholders to register as Interested and Affected Parties (I&APs) and consider or comment on the proposal started on 22 February. The cut-off date is 25 March.

Local concerns

Mossel Bay municipal manager Adv Thys Gillomee has asked residents to remain objective and consider the advanced technology which will be used - similar to what is already being used at the same type of plants in harbour towns, which have been in operation for some time.

Locals who have approached the *Mossel Bay Advertiser* have, however, vehemently complained about the potential impact of the fish meal factory, especially on the tourism industry.

They fear it may negatively impact plans for the harbour redevelopment into a waterfront and surmise that job losses in the tourism industry will far outstrip the potential employment gains proposed.

Residents fear the rotten fish odours associated with fish meal plants the world over will negatively impact their quality of life and devalue their seaside properties. Local experience of the existing fish meal

plant in Mossdustralia exacerbates these concerns.

"For a town whose livelihood so heavily depends on the seasonal tourism sector, where huge investments are made, also by Mossel Bay Tourism and the municipality into tourism, town festivals and the marketing of the area as a choice tourism destination, it is difficult to imagine that investment can be negated and played off against the creation of some 200 jobs.

"The potential job losses in the tourism industry far outstrip that figure," a businessman who preferred to remain anonymous, said.

The Cape Environmental Assessment Practitioners (Cape EAPrac) have been appointed as the independent Environmental Assessment Practitioner (EAP) to facilitate the legally required Environmental Application Process in terms of the relevant legislation. The competent authority, in this case, is the Western Cape Department of Environmental Affairs and Development Planning (DEA&DP) and the Garden Route District Municipality.

In a background document on the proposed development Cape EAPrac said expansion of the current Afro Fishing

facility to include fish meal and oil reduction processes was proposed on the current footprint of the old I&J facility, with a new canning store adjacent to the current Afro Fishing store.

Sole purpose

Afro Fishing proposes the harvesting of industrial fish such as anchovy, red-eye, and the like from local waters for the sole purpose of producing fish meal and fish oil.

The expansion project will include the fish meal and oil reduction plant; a fish freezing

plant; cold storage; a fish meal warehouse, and a new canned product warehouse.

The proposed alterations will allow Afro Fishing to process 1 000 tons per day of raw fish. The reduction process will include the following unit operations:

- Cooking
 - Pressing
 - Liquid-solid separation
 - Steam drying
 - Waste heat evaporation
 - Oil-liquid separation
 - Cooling / grinding / bagging
 - Boilers for steam generation
- Cape EAPrac states that Afro Fishing (Pty)



Ltd envisages an investment of R300m to R350m in this project.

The investment will diversify Afro Fishing into other fishing, namely anchovy, sardinella and red-eye herring. The proposed project will produce fish meal and fish oil products for export markets, with the expansion potentially increasing direct employment from the current 341, to approximately 560 persons.

Cape EAPrac also said the project will increase the canned fish production of which a large percentage of the canned fish production goes into the National Schools Nutrition Programme, where Afro Fishing supplies "affordable protein" for school

feeding

Odour control

The design of the plant, especially the use of RTO (re-generative thermal oxidation), is said to be based on a similar facility, Nareiso Dias & Filhos, LDA, located in Peniche, Portugal.

The reason for this is due to the similarity in location - a seaside town with tourism as a main driver for the economy.

The use of RTO in the plant led to significantly improved odour control and eliminated offensive odours previously experienced.

The RTO destroys hazardous air pollutants (HAPs), volatile organic compounds (VOCs) and odorous emissions.

The harbour is zoned as Transport 1 with various consent uses. The expansion of the Afro Fishing facility to include a fishmeal and oil reduction facility will require consent for use and other planning approval from the Mossel Bay Municipality.

Petition against fish meal plant in Mossel Bay's harbour

The application by Afro Fishing (Pty) Ltd. to establish a fish meal and fish oil manufacturing plant on the old I&J premises on Quay 1 of the Mossel Bay harbour caused such a public outcry that Mosselbayontheline was urged by several readers to launch a petition in order to prevent such a "short-sighted catastrophe from killing the town's thriving tourism industry and livelihood".

Local home and holiday home owners, as well as business owners, fear they will be left in the same position as residents in Hout Bay, Gansbaai and Saldanha Bay where all attempts, appeals, and lengthy court cases to curb the *unbearable stink that invariably goes hand in hand with such an industry* came to nothing.



They are also concerned about the impact on their property value, the pristine environment and that a fish meal factory will create much fewer job opportunities than it will cut jobs when restaurants and tourism industries have to close their doors due to the stench.

Questions are also raised about the viability and practicality of such an industry next to a planned multi-billion-rand-project to upgrade and enlarge the harbour area into an upmarket waterfront and tourism Mecca.

Afri Fishing, the current owner of the canning factory in the Mossel Bay harbour, also plans to expand the canning factory to accommodate red herring, anchovy and other fish species for the international export market.

While everybody supports job creation and the potential economic injection of such an industry, the majority is against the location and its negative impact on existing businesses, residents, the environment and especially tourism.

The ongoing battle of residents in other coastal towns where similar fish meal factories are operating should be a fair indication and timeous warning of the widespread impact of such a plant.

The biggest concern is the proven inability of the respective authorities to police, monitor and enforce all the legal procedures and legislation pertaining to such an industry.

Another concern is the ongoing drought and where the water for such water-intensive industries must come from.

Last year, two desalination plants were launched at Lucky Star's cannery and fish meal operations on the West Coast to relieve their dependence on the West Coast district municipality's water supply . . . Is the same route going to be followed in Mossel Bay?

People complained that such unobtrusive notices in a community paper, as well as the short deadline times for objections, are grossly unfair and suspicious, as only a handful of affected parties see or read such official notices and by the time they become aware of the implications of such an industry, it is too late to object.

"What about homeowners living abroad or elsewhere in the country? How must they know about plans for such ambitious industries that pose disastrous threats to their property value and quality of life in order to object timeously?"

Mosselbayontheline was bombarded with comments and questions from concerned residents after we wrote about Afro Fishing's plans; and within hours after we launched the petition, more than 100 have signed it and over 300 recommended the petition.

Here are some of the public commentaries and objections:

It's not a simple situation and job creation in the short term is not the only determining factor... it will need good and thorough planning to be successful!"*

- *"This is not about eating fish or stopping fishing. It's about a smelly fish meal (not for human consumption) plant in an area that is dependent on tourism. Tourists do not go to smelly places to spend their money."*
- *"All I'm concerned about is the location of the plant. Right in the tourist area. Some weeks ago there was talk of enlarging the harbour to accommodate the large cruise ships that come here. That would then become a rather pointless development as tourists will not enjoy the smell. What about an alternative position for the plant, Mosdustrya? Then you can create additional jobs for transporting fish to the plant etc."*
- *Tourism is the goose that keeps laying golden eggs, killing it is not a wise thing."*
- *"That smell!!! Be like St Helena ...and when the breeze blows towards town...you guys better run.... lock up ..everything is going to smell fishy!!!! No thanks. If it was on the outskirts of town different setup altogether."*
- *"Jy gaan argumentsonthalwe, 50 werksgeleenthede skep. Maar, nou stink Mosselbaai en besoekers bly weg. Hoeveel mense gaan hulle werk dan verloor? 'n 1000? 10000? Ter wille om net 50 werk te gee. Kyk na die groter prentjie en die skade wat dit kan berokken."*

Underneath is a link to the petition that we launched late last night on public demand. Within hours, more than 130 people signed it and over 340 recommended the petition.

Residents feel the potential impact of the stinky fish meal factory on the tourism industry and the overall image of the town as a coveted holiday destination, will be devastating.

If you are against this industry, please sign the petition and give reasons why you object to its establishment. We need as many petitioners as possible to stop this smelly business in its tracks before it's too late!

Afro Fishing is located on Quay 1 of the Mossel Bay Harbour. The development property is immediately adjacent to the west which was previously utilised by I&J.

The existing buildings will be demolished to accommodate the new development which will have a slightly smaller footprint. The property was put out on tender for commercial / industrial use by Transnet National Ports Authority (TNPA) as owners of the harbour facility.
