Good day Mr. Byleveld,

Your invitation for comment on the abovementioned proposed development refers.

- 1. We confirm the availability of 100kVA electrical capacity as per our letter dated 11 Feb 2020.
- 2. Depending on budget constraints, it is envisaged that the overhead line running along Morrison Rd and the northern boundary of Erf 720, will be replaced with an underground cable in the next 2-3 years. Construction work on the overhead line replacement project will start on 26 Sep 2023 at a point approximately 1900m east of this development.

We therefore propose that allowance be made for ground mounted equipment for the bulk electrical connection to this development, instead of the pole mounted transformer and overhead MV connection referred to in the Electrical Services report.
