


Hi Good Afternoon Mushfiqah!

Quick question on the applicability of OSCA for Tergniet (I tried to verify on the MossBay GIS system but it appeared to be down this morning because I could not activate some of the layers?).

Erf 2841 and 137/51 – are they part of the OSCA area on your books? I'm getting a protected tree survey done for these properties on Monday, but the owner asked if he could in the mean time conduct hand clearing of invasive alien vegetation to improve the quality of the protected tree survey.

- 1. Can you confirm if these properties are within the OSCA area and
- 2. For invasive alien vegetation clearing (by hand only), do you require an OSCA permit?
